Student Contract Erasmus Mundus Scholarship (European Master's Program in Computational Logic)

The Technische Universität Dresden (TUD), coordinating institution of the Master's Program, hereafter referred to as "the Institution", represented in the present contract by Prof. Dr. rer. nat. habil. Steffen Hölldobler as the "First Signatory", and

hereafter referred to as "the Student" (respective as "Second Signatory"), conclude the present contract under the following terms and conditions:

- 1. In order to participate in the European Master's Program in Computational Logic (EMCL), which is approved as Erasmus Mundus Masters Course by the European Commission, the Student receives a scholarship according to the enclosed letter of award which is part of this contract. The EMCL program is run by the following consortium partner universities: the Technische Universität Dresden in Germany, the Free-University of Bozen-Bolzano in Italy, the Universidade Nova de Lisboa in Portugal, the Technische Universität Wien in Austria and the National ICT in Australia.
- 2. All important details on the study program such as the study and examination regulations, the curriculum, the semester dates, the nature of exams, the use of the ECTS grading system, the conditions under which the student is considered to be underperforming etc. are provided by the study booklet "All about EMCL" which is available on the web pages: http://www.emcl-study.eu/fileadmin/emcl_booklet_tree/.
- 3. The payment of the grant is explained in detail by the letter of award and should start up to 30 days after the beginning date of the program provided that the Student
 - has officially enrolled at the Institution and the consortium partner university where he/she is physically studying and
 - has informed the Institution about his/her bank account within the European Union (see attached bank data form).

4. Student's obligation

Under the present contract, the Student is obliged

- to attend the EMCL program having a duration of two academic years and beginning on 1 October 2011 -, in accordance with the EMCL's common study and examination regulations at the consortium partner universities,
- to study at least at two of the consortium partner universities. The hosting countries must be different from the country where he/she obtained his/her last university degree,

- to enroll full-time in the EMCL-Program,
- to obtain the requested number of ECTS credits at the end of each semester.
- to study seriously with the objective of successfully passing all examinations in relation to the common study and examination regulations,
- to write a short report (of about three pages) at the end of each semester (by 30 March and 31 August) which must contain information on the courses attended, grades received, number of credits achieved as well as on other activities and experiences within EMCL,

and he/she must inform in writing the Institution immediately on

- any academic, medical or personal reasons for extended absence,
- any vocational occupation with a regular salary in parallel to the studies,
- any additional financial support schemes provided by the European Commission,
- any change of his/her private address including his/her private email address.

5. Measures in case of failure

- Any deliberate failure on part of the Student to fulfill the conditions stipulated by the present contract constitutes sufficient reason for action to be taken towards resolving this contract and could lead to reimbursement of the scholarship awarded.
- In case of reimbursement, the Institution will determine the amount to be reimbursed.
- The consortium reserves the right to discontinue payments in case of
 e. g. lack in active participation, additional financial support schemes
 provided by the European Commission, underperforming.

6. Consortium's obligation

Under the present contract, the consortium

- partner universities mutually recognize the Student's study times, study and examination achievements on the basis of modules, master theses and final grades,
- provides the mobility placements at least at two consortium partner universities,
- guarantees the award of joint degrees after successful completion of the program,
- ullet offers an appropriate insurance scheme,
- supports the Student in relation to housing and visa procedure and offers integration service to the Student, his/her family and students with special needs.

7. General terms

- The Student cannot benefit from another grant financed by the European Commission while pursuing his/her Erasmus Mundus master studies
- The Student is not entitled to embark on any vocational occupation with a regular salary in parallel to the studies without prior approval by the consortium. The student must declare that he/she can still participate in the Master Course in order to complete the studies within the agreed period.
- The scholarship does not create or entitle an employer-employee relation between the Institution and the Student, and therefore, it is not subject to direct taxation.
- All personal data may be transferred to the European Commission on request.
- Any alteration of the present contract must be communicated in writing. All alterations of the initial situation must be immediately communicated by the Student to the Institution. Upon mutual agreement of contractual modifications, the Institution will issue an adendum to the present contract.
- Failing agreement by both parts, the German courts are designated as the only competent authorities to resolve any legal dispute between the Institution and the Student emerging from the contract. The present contract will be governed by German Law.
- The Institution is exonerated from any responsibility for accidents, illnesses, injuries, losses or damages to persons or goods resulting from or in any way related to the activities that are the object of the present contract. The Student is obliged to accept the necessary insurance related to the activities for the full duration of the study period.
- The cancellation of the scholarship will lead to the termination of the insurance coverage.

The signatories declare that they have read and accept the conditions and terms laid down in the present contract.
